

Everything Is Going to Be Alright

Hello to my loved ones, friends and other visitors to my website. This is my fourth blog post since the first one and, the opening of this site on or around December 25th of 2025. It is with a heavy heart that I will update you all on some of the devastating news I received from the Doctor that presides over my medical file currently, Dr. Pratt.

It has become obvious to me that I can no longer trust or confide in this system at all. My entire medical file, which is easily 5000 pages, is a complete and total lie. Ironically, what I said is about the only truth about it.

Recently I was approached by Doctor Pratt to discuss my behavior and capacity for treatment. This system has willfully made millions off of me being incarcerated in it, which includes salaries of any and all employees with in it or connected to it in any fashion, and they made that money off my back while I endured excruciating and devastating human pain and suffering, as well as damages to my brain, mind, and body, that will never recover. Notwithstanding that every relationship I have had for the last 9 years, has either been one of a clinical professional nature, or completely ripped from my arms and my emotions and actions to express the boundless love I have for the people I choose to give it to, have been completely invalidated and destroyed by everyone who said I was psychotic for the soul purpose of doing just that.

Please forgive the entitlement I feel to the right to choose my medication Dr. Pratt, but I'm certain anyone in my cognitive capacity range with 18 years experience of taking the anti-psychotic medication you are trying to inject me in the ass with against my will, has more than enough understanding to tell you that, for the love of God no I do not want that debilitating, mind numbing emotion killing, poison in my body. If that is the case Dr. Pratt you had better be prepared to defend yourself very well on the stand at my trial and I most certainly expect you to be there.
